The sum of **\$240.00** has been paid into the Permanent Fund of the Winterset Cemetery Improvement Association in full payment of all charges to the above-named grantee for annual care of the cemetery space covered by this deed.

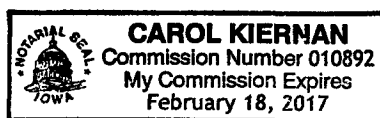
