This agreement is entered into this 17th day of March, 2015 by and between Madison County Board of Health and Kyle Kuhns.



WHEREAS, the property located at 2325 Carver Road also described as Parcel A in the NE ¼ of the NW ¼ of Section 12 Lincoln Township has a septic system that does not meet the requirements of a properly working system, and the buyer Kyle Kuhns understands the system did not pass an inspection.

NOW THEREFORE, it is hereby agrees that the necessary private sewage disposal system to serve the property shall be installed and completed no later than the 1st day of July 2015.

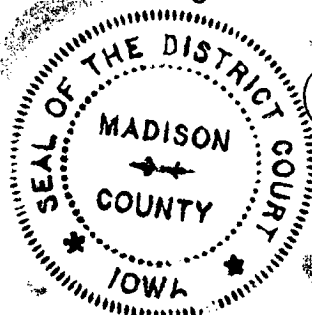
