## SECOND AMENDMENT TO BUILDING RESTRICTIONS AND RESTRICTIVE COVENANTS FOR CLANTON CREEK CORNER SUBDIVISION

The Building Restrictions and Restrictive Covenants, running with the land, as part of the Subdivision proceedings for Clanton Creek Corner Subdivision, in Book 2007, Page 930 of the Recorder's Office of Madison County, Iowa, state that said Covenants may be amended by a two-thirds vote of the lot owners within the Subdivision.
