are now the record titleholders of the following described real estate situated in

Warren A. Piatt died on March 27, 2005, and was, at the time of his death, a resident of Dallas County, Iowa. On April 7, 2005, the Last Will and Testament of Warren A. Piatt was admitted to probate in Dallas County, Iowa, under the Probate No. ESPR021192 and the undersigned Keith A. Piatt was appointed executor of the estate. Under Article IV of the Last Will and Testament of Warren A. Piatt, the real property described above covered by this Affidavit was specifically devised to Keith A. Piatt. Pursuant to that Last Will and Testament, Keith A. Piatt, as executor, conveyed to himself by Court Officer Deed the real property covered by this Affidavit. This Court Officer Deed was from the Estate of Warren A. Piatt, Deceased, Keith A. Piatt, executor, to Keith A. Piatt, as Grantee, and was dated May 6, 2006, and filed May 10, 2006, in Book 2006 on Page 1846 in the Office of the Madison County, Iowa, Recorder. It specifically and accurately states on the face of the Court Officer Deed that: "This Deed is given to transfer a distribution of assets to a devisee, or devisees, under a Will." The estate was not subject to federal estatax or Iowa Inheritance Tax. At the present time, more than 10 years have passed since the death of Warren A. Piatt on March 27, 2005.

are now in complete actual and sole possession of all of said real estate except as may be herein stated.
