



DESCRIPTION PARCEL 5

A perpetual easement for road purposes and for the use as a public highway located in that part of the Southwest Quarter of the Southwest Quarter of Section 25, Township 74 North, Range 28 West of the Fifth Principal Meridian, Madison County, Iowa, described as follows:

Beginning at the southwest corner of the Southwest Quarter of the Southwest Quarter of said Section 25;

thence North 00 degrees 31 minutes 09 seconds East along the westerly line of said Southwest Quarter of the Southwest Quarter 121.97 feet to the centerline of a Madison County Highway;

thence southeasterly 130.50 feet along the centerline of a Madison County Highway and a curve concave to the southwest and not tangent with the last described line, said curve has a radius of 850.00 feet, a central angle of 8 degrees 47 minutes and 49 seconds, chord bearing and length of South 79 degrees 27 minutes 44 seconds East 130.38 feet;

thence South 75 degrees 03 minutes 49 seconds East along said centerline 240.77 feet;

thence southeasterly 8.45 feet along said centerline and a curve concave to the northeast and tangent with the last described line, said curve has a radius of 1000.00 feet, a central angle of 0 degrees 29 minutes and 03 seconds, chord bearing and length of South 75 degrees 18 minutes 21 seconds East 8.45 feet; thence South 00 degrees 00 minutes 00 seconds East 34.04 feet to the present right of way line of a Madison County Highway and the southerly line of said Southwest Quarter of the Southwest Quarter;

thence North 89 degrees 58 minutes 51 seconds West along said southerly line 332.50 feet to the present right of way line of a Madison County Highway; thence North 89 degrees 58 minutes 51 seconds West along said southerly line 37.59 feet to the southwest corner of the Southwest Quarter of the Southwest Quarter of said Section 25 and the point of beginning.

Said tract contains 0.70 acres including the present highway and is subject to encumbrances of record.
