This Memorandum of Lease, made and entered into by and between Bradley Robinson ("Lessor") and FMO Real Estate, LLC ("Tenant") with an office located at 814 Duncan-Reidville Road, Duncan, SC 29334.

The parties have entered into a certain lease agreement dated <u>November 16, 2015</u> ("Lease Agreement"), which Lease Agreement is hereby incorporated into and made a part of this Memorandum of Lease.

Under the Lease Agreement, the Lessor rents to Tenant the following described property: Being a portion of the real property ("the Lessor's Tract") located at <u>SR 92 N/S 2mi E/O CR P53</u> and described in deed with parcel #340063160062000, Madison County Registry. ("The Leased Premises") The legal Description being W4125.5' S528' SW Corn SW SW EX HWY 5.00A. The Lessor does hereby grant to the Tenant, its employees and agents, an irrevocable license during the term of this Lease Agreement to access the Leased Premises over the Lessor's Tract with labor and machinery using such routes which are practical and reasonable as determined in Tenant's sole discretion.

The Tenant rents the Leased Premises for the purposes of erecting, maintaining, repairing, improvement, replacing and rebuilding one (1) outdoor advertising structure.

Under the Lease Agreement, the Original Term is TEN (10) years, commencing on June 1, 2016.
