# RESOLUTION PROPOSING TO VACATE A PORTION OF A CITY STREET RIGHT OF WAY AND SETTING PUBLIC HEARING ON THE PROPOSAL

WHEREAS, the City proposes to vacate a portion of 5th Avenue, a City street right-of-way, and to dispose of its interest in the real estate formerly used as a City street right-of-way;

WHEREAS, the portion of the City street right of way to be vacated is legally described as:

Parcel "M" a part of 5th Avenue a street through Lindsey Addition to the City of Winterset, Madison County, Iowa more particularly described as follows:

Beginning at the Southeast Corner of Lot 6 of Lindsey Addition to the City of Winterset, Madison County, Iowa, thence North 00°13'48" East 198.86 feet along the East line of said Lot 6 and the South Half of Lot 5 which is the West line of 5th Avenue right-of-way; thence South 89°38'55" East 60.08 feet to a point on the West line of Lot 8 of said Lindsey Addition; thence South 00°13'48" West 199.19 feet to the Southwest Corner of Lot 7, Lindsey Addition; thence North 89°19'09" West 60.08 feet along the North line of Husky Drive to the Point of Beginning, containing 0.275 acres.

WHEREAS, the Iowa Code Section 354.23 requires a public hearing be held on the proposal to vacate a portion of a City street right of way and that public notice be made on the proposal.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Winterset, Iowa that a proposal is hereby made to vacate a portion of a City street right-of-way as described above.

BE IT FURTHER RESOLVED that a public hearing before the City Council on this proposal shall be held on February 15, 2016, at 7:00 PM., at the City Hall, 124 West Court Avenue, Winterset, Iowa.

WHEREAS, the City Council of Winterset, Iowa has proposed to vacate a portion of a City street right-of-way described as follows:

Parcel "M" a part of 5th Avenue a street through Lindsey Addition to the City of Winterset, Madison County, Iowa more particularly described as follows:

Beginning at the Southeast Corner of Lot 6 of Lindsey Addition to the City of Winterset, Madison County, Iowa, thence North 00°13'48" East 198.86 feet along the East line of said Lot 6 and the South Half of Lot 5 which is the West line of 5th Avenue right-of-way; thence South 89°38'55" East 60.08 feet to a point on the West line of Lot 8 of said Lindsey Addition; thence South 00°13'48" West 199.19 feet to the Southwest Corner of Lot 7, Lindsey Addition; thence North 89°19'09" West 60.08 feet along the North line of Husky Drive to the Point of Beginning, containing 0.275 acres.

WHEREAS, the City Council has set the date for a public hearing upon the proposal to vacate a portion of a City street right-of-way pursuant to Iowa Code Section 354.23;

WHEREAS, notice of the hearing has been published as provided by Iowa Code Section 362.3 in the Winterset Madisonian which is a newspaper published weekly and having general circulation in the City, not less than four (4) days nor more than twenty (20) days before the date of hearing as evidenced by the Affidavit of Publication from the Madisonian on file in the Office of the City Administrator;

WHEREAS, the public hearing has been held and all interested persons have been heard on the proposal,

WHEREAS, the City Council now determines that the vacation of a portion of a City street right-of-way as described above should be approved in all respects as proposed.
