The Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$) and all that part of the East Half of the Southeast Quarter (E $\frac{1}{2}$ SE $\frac{1}{4}$) of Section 29, Township Seventy-six (76) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa, lying North of Iowa Primary Highway #92 as now located over and across said tract EXCEPT a parcel located in the said East Half (E $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$), containing 3.000 acres, as shown in Plat of Survey filed in Plat Book 2, Page 217 on September 26, 1990, in the Office of the Recorder of Madison County, Iowa, AND EXCEPT the East 24 feet lying East of said Plat of Survey filed in Plat Book 2, Page 217,
