

## **ADDENDUM**

All that part of the Southeast Quarter (¼) of the Northwest Quarter (¼) of Section Twenty-two (22), Township Seventy-five (75) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa, lying East of the right of way of the Chicago, Great Western Railroad Company and containing 17 acres more or less; **AND** Lots One (1) through Nineteen (19), inclusive, in Block Seven (7), **AND** Lots Thirty-two (32) through Thirty-six (36), inclusive, and the North Half of Lot Thirty-one (31) in Block Eight (8), ALL in the Town of Hanley (originally platted as West St. Charles), Madison County, Iowa; **AND** those parts of vacated Olive Street and alley in the Town of Hanley (originally platted as West St. Charles), Madison County, Iowa, more particularly described as follows, to-wit:
