

LEGAL DESCRIPTION:

Parcel "A" in the Southeast Quarter of the Northeast Quarter of Section 3, Township 76 North, Range 26 West of the 5th P.M., Madison County, Iowa more particularly described as follows:

Beginning at the East Quarter Corner of Section 3, Township 76 North, Range 26 West of the 5th P.M., Madison County, Iowa thence South 84°47'31" West 309.11 feet along the South line of the Southeast Quarter of the Northeast Quarter of said Section 3, thence North 01°18'35" West 214.58 feet; thence North 21°20'25" East 355.80 feet; thence North 84°47'31" East 171.78 feet to a point on the East line of said Southeast Quarter of the Northeast Quarter; thence South 01°18'33" East 533.60 feet to the Point of Beginning containing 3.276 acres including 0.234 acres of County Road right-of-way.

LEGAL DESCRIPTION ACCESS EASEMENT:

A 30.00 foot wide Access Easement the perimeter of which is described as follows:

Beginning at the County Road right-of-way marker on the Southwest side of Parcel "A"; thence North 01°18'35" West 181.50 feet along the West line of Parcel "A"; thence North 21°20'25" East 77.82 feet; thence South 01°18'35" East 251.28 feet to a point on the County Road right-of-way; thence South 84°47'31" West 30.04 feet to the Point of Beginning.
