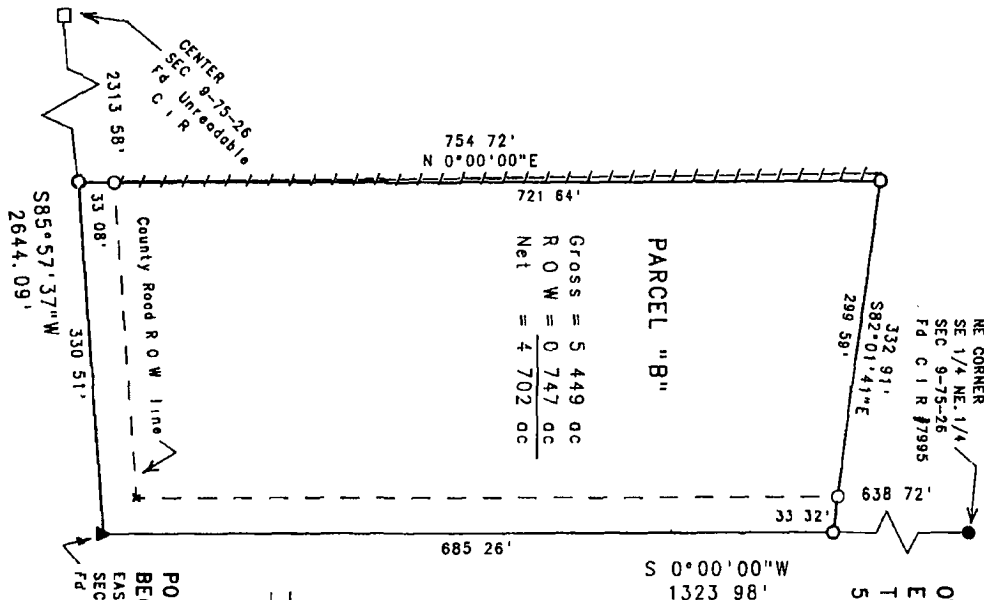

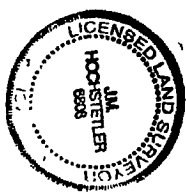
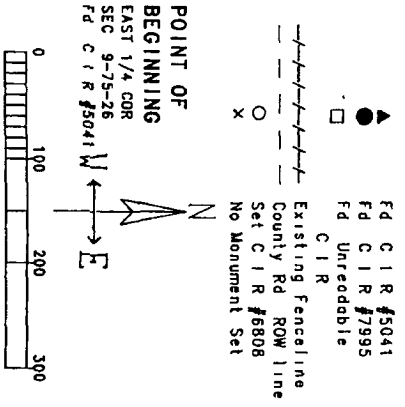

**LEGAL DESCRIPTION**  
 Parcel "B", located in the Southeast Quarter of the Northeast Quarter of Section 9, Township 75 North, Range 26 West of the 5th P.M., Madison County, Iowa, more particularly described as follows:  
 Beginning at the East Quarter corner of Section 9, Township 75 North, Range 26 West of the 5th P.M., Madison County Iowa, thence South 85°57'37" West, 330 51 feet along the South line of the Northeast Quarter to the Southeast corner of the East one-fourth of the Southeast Quarter of the Northeast Quarter of said Section 9, thence North 0°00'00" East, 754 72 feet along the West line of the East one-fourth of the Southeast Quarter of the Northeast Quarter of said Section 9, thence South 82°01'41" East, 332 91 feet to a point on the East line of the Southeast Quarter of the Northeast Quarter of said Section 9, thence South 0°00'00" West, 685 26 feet along the East line of the Southeast Quarter of the Northeast Quarter of said Section 9 to the Point of Beginning. Said parcel contains 5 449 acres, including 0 747 acres of County Road right-of-way.
