NOTE: This is an exempt transaction pursuant to dissolution of marriage decree (Madison County CDDM006328).

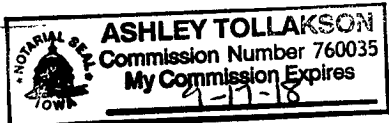
