with the laws of this State.

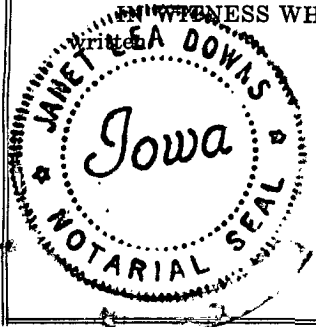
