- I, Melvin R. McNichols, being first duly sworn on oath, depose and state as follows:
- 1. I am the Executor of the Estate of Florence L. McNichols.
- 2. Florence L. McNichols was the surviving spouse of Wilbur W. McNichols, who died on August 14, 2014.
- 3. The following described real estate was owned only by Wilbur W. McNichols and Florence L. McNichols, as Joint Tenants with Full Rights of Survivorship, and not as Tenants in Common, at the time of Wilbur W. McNichols's death:
