A tract of land located in the Northeast Quarter (1/4) of the Southwest Quarter (1/4) of Section Thirty-six (36), Township Seventy-six (76) North, Range Twenty-eight (28) West of the 5th P.M., City of Winterset, Madison County, Iowa, and more particularly described as follows, to-wit: Commencing at the Southeast Corner of the Northeast Quarter (1/4) of the Southwest Quarter (1/4) of said Section Thirty-six (36), thence West 823.5 feet, thence North 386 feet to the Southwest corner of Lot Eleven (11) of Second West Court Addition to the City of Winterset and the Point of Beginning, thence West 120 feet to the Southeast corner of Lot One (1) of Corkrean Addition to the City of Winterset, thence North 30 feet, thence East 120 feet to a point on the West line of said Lot Eleven (11) of Second West Court Addition to the City of Winterset, thence South 30 feet to the point of beginning.
