



That part of Parcel B recorded in Book 2002, Page 3427, Madison County Recorder's Office, Madison County, Iowa located in the Northwest Quarter of the Northeast Quarter of Section 20, Township 77 North, Range 26 West of the Fifth Principal Meridian, Madison County, Iowa, described as follows:

Beginning at the southwest corner of said Parcel B and the southwest corner of the Northwest Quarter of the Northeast Quarter of said Section 20; thence on an assumed bearing of North 00 degrees 08 minutes 01 seconds East along the westerly line of said Parcel B and the westerly line of the Northwest Quarter of the Northeast Quarter of said Section 20 a distance of 220.00 feet to the northwest corner of said Parcel B;

thence North 83 degrees 20 minutes 43 seconds East along the northerly line of said Parcel B 49.36 feet to the present right of way line of a Madison County Highway;

thence North 83 degrees 20 minutes 43 seconds East along said northerly line 76.53 feet;

thence South 00 degrees 08 minutes 01 seconds West 11.99 feet;

thence South 23 degrees 33 minutes 45 seconds West 163.48 feet; thence South 00 degrees 08 minutes 01 seconds West 65.78 feet to the southerly

line of said Parcel B and the southerly line of the Northwest Quarter of the
