



DESCRIPTION PARCEL 4

That part of the Northwest Quarter of the Northeast Quarter of Section 20, Township 77 North, Range 26 West of the Fifth Principal Meridian, Madison County, Iowa, described as follows:

Commencing at the southwest corner of the Northwest Quarter of the Northeast Quarter of said Section 20;

thence on an assumed bearing of North 00 degrees 08 minutes 01 seconds East along the westerly line of the Northwest Quarter of the Northeast

Quarter of said Section 20 a distance of 220.00 feet to the northwest corner of Parcel B recorded in Book 2002, Page 3427, Madison County Recorder's Office, Madison County, lowa and the point of beginning;

thence North 00 degrees 08 minutes 01 seconds East along said westerly line 702.89 feet;

thence South 89 degrees 51 minutes 59 seconds East 45.96 feet to the present right of way line of a Madison County Highway;

thence South 15 degrees 33 minutes 13 seconds East 51.93 feet;

thence South 01 degrees 46 minutes 32 seconds East 150.08 feet; thence South 04 degrees 37 minutes 50 seconds East 301.00 feet;

thence South 34 degrees 50 minutes 08 seconds East 61.07 feet;

thence South 00 degrees 08 minutes 01 seconds West 138.01 feet to the northerly line of said Parcel B;

thence South 83 degrees 20 minutes 43 seconds West along said northerly line 76.53 feet to the present right of way line of a Madison County Highway; thence South 83 degrees 20 minutes 43 seconds West along said northerly line 49.36 feet to the northwest corner of said Parcel B and the westerly line of the Northwest Quarter of the Northeast Quarter of said Section 20 and the point of beginning.

Said tract contains 1.35 acres including the present highway and is subject to encumbrances of record.
