## MEMORANDUM OF REAL ESTATE LEASE & WIND EASEMENT

WHEREAS, Jeff K. Bellamy and Stephanie L. Bellamy, owner of an undivided one-half interest, husband and wife, and Bruce A. Bellamy and Georgine E. Bellamy, owner of an undivided one-half interest, husband and wife, [GRANTORS] (hereinafter "Lessor"), and Roseman Energy, LLC, an Iowa limited liability company [GRANTEE] (hereinafter "Lessee"), did on or about the day of \_\_\_\_\_\_\_\_, 2016, make, execute and deliver a REAL ESTATE LEASE & WIND EASEMENT ("Lease Agreement"), with respect to certain real property located within the County of Madison, lowa, more particularly described as follows:
