Dunham, as tenants in common, all of our right, title, interest, estate, claim and demand in the following described real estate in Madison County, Iowa:

The East Half (½) of the Northwest Quarter (1/4) of the Southwest Quarter (1/4) and the South Half (½) of the Northeast Quarter (1/4) of The Southwest Quarter (1/4) of Section Thirteen (13) in Township Seventy-seven (77) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, except commencing at a point 1320 feet West and 660 feet South of the Northeast corner of the Northeast Quarter (1/4) of the Southwest Quarter (1/4) of said Section Thirteen (13), thence East 513 feet to the point of beginning, thence South 24° 24' East 493.81 feet, thence North 79° 45' East 612.79 feet, thence North along the East side of said 40 acre tract to a point 660 feet South of the Northeast corner of the Northeast Quarter (1/4) of the Southwest Quarter (1/4), thence West 807 feet to the point of beginning and containing 6.52 acres more or less including the present highway.
