For the consideration of ONE Dollar(s) and other valuable consideration, **Todd C. Town and Deborah A. Town, Trustees of the Town Family Trust dated August 28, 2000** do hereby convey to **Bryan Brackemyer and Megan Brackemyer, a married couple, as joint tenants with full rights of survivorship and not as tenants in common** the above-described Real Estate.
