## ADDENDUM

The East Half (½) of the Southeast Quarter (¼) of Section Twenty-five (25), Township Seventy-four (74) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa, EXCEPT a tract of land located in the Southeast Quarter (¾) of the Southeast Quarter (¾) of said Section Twenty-five (25), described as follows, to-wit: Beginning at the Southeast corner of said Section Twenty-five (25), running thence South 85°59'10" West 1317.18 feet along the South line of the Southeast Quarter (¾) of the Southeast Quarter (¼) of said Section Twenty-five (25) to the Southeast Quarter (¼) of said Section Twenty-five (25) to the Southeast Quarter (¼), thence North 86°00'15" East 1323.73 feet to the East line of said Southeast Quarter (¼) of the Southeast Quarter (¼), thence South 660 feet along the East line to the point of beginning, containing 19.96 acres, more or less, including public roads; AND the Southeast Quarter (¼) of the Northeast Quarter (¼) of said Section Twenty-five (25); AND all that part of the Southwest Quarter (¼) of the Northeast Quarter (¼) of said Section Twenty-five (25) which lies East of the public road running through said forty acre tract.
