

Lot One (1) of Lanny Wenck Addition to the City of Winterset, Madison County, Iowa, AND a parcel of land located in the East Half ( $\frac{1}{2}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of Section Thirty-six (36), Township Seventy-six (76) North, Range Twenty-eight (28) West of the 5<sup>th</sup> Principal Meridian, City of Winterset, Madison County, Iowa, more particularly described as follows: Commencing at the Northeast Corner of said Section Thirty-six (36); thence along the North line of the Northeast Quarter ( $\frac{1}{4}$ ) of said Section Thirty-six (36), North  $90^{\circ}00'00''$  West, 659.53 feet; thence South  $0^{\circ}20'55''$  East, 115.94 feet to the point of beginning; thence continuing South  $0^{\circ}20'55''$  East, 211.35 feet; thence South  $90^{\circ}00'00''$  East, 14.01 feet; thence North  $0^{\circ}02'47''$  West, 210.50 feet; thence along the South Highway Right of Way line, North  $86^{\circ}47'11''$  West, 15.15 feet to the point of beginning.
