Parcel "D", being the South Half (1/2) of the Northeast Quarter (1/4) of the Northwest Quarter (1/4) of Section Twenty-two (22), Township Seventy-four (74) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, AND Parcel "E". being the Southeast Quarter (1/4) of the Northwest Quarter (1/4) of said Section Twenty-two (22), lying East of the center line of the road, containing 4.11 acres and 5.86 acres, respectfully, as shown in Plat of Survey filed in Book 2016, Page 2435 on August 24, 2016 in the Office of the Recorder of Madison County, lowa; AND a tract of land located in the Southwest Quarter (1/4) of the Northeast Quarter (1/4) of said Section Twenty-two (22), more particularly described as follows, to-wit: Commencing at a point on the West line of the Northeast Quarter (1/4) of said Section Twenty-two (22), where the Eastern right-of-way line of the former Chicago & Northwestern Transportation Company (formerly Chicago Great Western Railway Company) Railroad intersects said quarter section line; thence Northeasterly along the Eastern right-of-way line of said former Railroad right-of-way a distance of 645 feet, more or less, to a point 77 feet Northeasterly of the Northern bridge abutment of the railroad bridge spanning Clanton Creek: thence West to the Western boundary of the Northeast Quarter (1/4) of said Section Twenty-two (22); thence South along the quarter section line to the point of commencement
