That the McDonald-Chase Cemetery Association of Douglas Township, Madison County, Iowa, in consideration of one dollar (\$1.00) and other valuable consideration does hereby convey to Dixie McDonald of Winterset, in the County of Madison and State of Iowa, or heirs, the following;

Lot Number 52 of the Chase Addition to the McDonald-Chase Cemetery Association in Douglas Township, Madison County, Iowa.

TO HAVE AND TO HOLD the herein above granted premises as a Place of Interment to the said Grantee and his or her heirs forever; subject however, to the Articles of Incorporation of said cemetery association which are of record as of August 23rd, 1951 at 10:45 A.M. and recorded in Book 25, on Page 434 of the Records of the County Recorder of Madison County, Iowa, and subject to such other rules and regulations as may hereafter be adopted by said association.

This conveyance is made to and accepted by the Grantee on the express condition that the same is to be used only as a place of interment, subject to all rules and regulations of said cemetery association.
