a plat of which is maintained as part of the records of the Winterset Cemetery Improvement Association in the office of its Sexton in Winterset, Madison County, Iowa, showing the original plat of said addition and such additional plats, replats, and/or changes as have heretofore been, or may hereafter be, made relative to the original plat on and of the grounds of said addition to said cemetery.

This conveyance is made to and accepted by the **grantees** on the express condition that the same is to be used as a place of interment and subject to all the rules and regulations of said Cemetery Improvement Association which are of record in the office of the County Recorder of Madison County, Iowa, and subject to such other regulations as have heretofore been, or may hereafter be, made by said Association affecting said cemetery.

The sum of **\$160.00** has been paid into the Permanent Fund of the Winterset Cemetery Improvement Association in full payment of all charges to the above-named grantee for annual care of the cemetery space covered by this deed.
