Parcel One (1) located in the Southwest Quarter (1/4) of the Southwest Quarter (1/4) of Section Two (2), Township Seventy-six (76) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, containing 18.6377 acres, AND Parcel Two (2) located in the Northwest Quarter (1/4) of the Northwest Quarter (1/4) of Section Eleven (11), Township Seventy-six (76) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, containing 3.8816 acres, both parcels as shown in Plat of Survey filed in Book 1, Page 126 on December 1, 1977, in the Office of the Recorder of Madison County, Iowa, EXCEPT the East 100 feet of said tract Two (2), all subject to Easements of record;
