Addendum

1. A tract of land described as follows: - Commencing at the exenter of Section Twenty-five (25), in Township Seventy-six (76) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa, running thence South 0° 06' 39" West along the quarter section line 398.33 feet to the North line of Iowa Highway #92, thence South 65° 06' 36" West along said North line 870.46 feet, thence North, 06° 27' 07" West. 671.03 feet to a point on the North line of the Southwest Quarter (½) of said Section, thence North, 83° 32' 53" East, along said North line 871.30 feet to the point of beginning and containing 1032 acres, more or less,

EXCEPT
