This agreement is entered into this 20th day of July, 2017 by and between Madison County Board of Health and George Potzner Phone # 515-971-9990



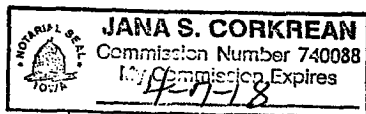
