Addendum

1. The Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of Section Thirteen (13), in Township Seventy-five (75) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa, EXCEPT a part of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of said Section Thirteen (13), more particularly described as follows, to-wit: Commencing at a point that is 240.0 feet West of the North Quarter (1/4) corner of said Section Thirteen (13), thence southwesterly along a 09°33' curve and distance of 497.03 feet; thence South 29°09' West 61.85 feet; thence South 83°48' West 633.0 feet; thence North 00°21'40" West 300.00 feet; thence North 83°48' East 812.00 feet to the point of beginning, containing 5.30 acres, more or less; AND EXCEPT a tract of land located in the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of said Section Thirteen (13), containing 6.4 acres, as shown in Plat of Survey filed in Book 2, Page 677 on May 1, 1996, in the Office of the Recorder of Madison County, Iowa.
