## **QUIT CLAIM DEED**

For the consideration of One and 00/100ths Dollars (\$1.00) and other valuable consideration, Mark Hawkins, a/k/a Mark V. Hawkins, and Kayla Hawkins, Husband and Wife, do hereby Quit Claim to KayMar Properties, LLC all our right, title, interest, estate, claim and demand in the following described real estate in MADISON County, Iowa:

Parcel "F" in the SW¼ SE¼ in Section Twenty-two (22), Township Seventy-seven (77), Range Twenty-seven (27) as recorded in Amended Plat of Survey, dated June 25, 1997, and recorded in Farm Plat Book 3 at Page 34 in the office of the Madison County Recorder.

This property will include water rights from the well on the adjacent Tract 4 (a/k/a Parcel "G") and said water rights will provide for a 50-50 sharing of operating expenses and repair expense. The owner of Tract 3 will not be obligated to share the cost of a new well should the present well fail unless agreed to at the time; however, the owner of Tract 3 (Parcel "F") will not have the rights to water from a new well by virtue of this Agreement. The Tract 3 (Parcel "F") owner may cancel this agreement at any time that alternative water is available to them whether by drilling their own well or by connecting to rural water.

This instrument is without actual consideration and is exempt from transfer tax under Iowa Code Section 428A.2(21).

Each of the undersigned hereby relinquishes all rights of dower, homestead and distributive share in and to the real estate.
