WHEREAS, Borrower has requested that the terms of the above-described note and mortgage be modified; and


WHEREAS, the Lender accepts the proposed modification of terms.

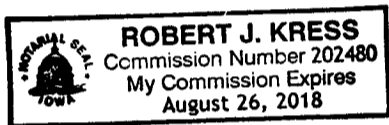
