## AFFIDAVIT OF SURVIVING JOINT TENANT FOR CHANGE OF TITLE TO REAL ESTATE

## STATE OF IOWA, COUNTY OF MADISON, ss:

- I, Debra Wignall, being first duly sworn on oath, depose and state as follows:
- 1. I am the surviving joint tenant of William Ray Wignall (the "Decedent"), who died on August 23, 2017.
- 2. The following described real estate was owned only by Decedent and this Affiant, as joint tenants with full rights of survivorship at the time of the Decedent's death:
  - A. Lot Twenty-five (25) and the North Half (N 1/2) of the West 62 feet of the vacated alley, in Block Four (4) of Danforth's Second addition to Winterset, Madison County, Iowa.
