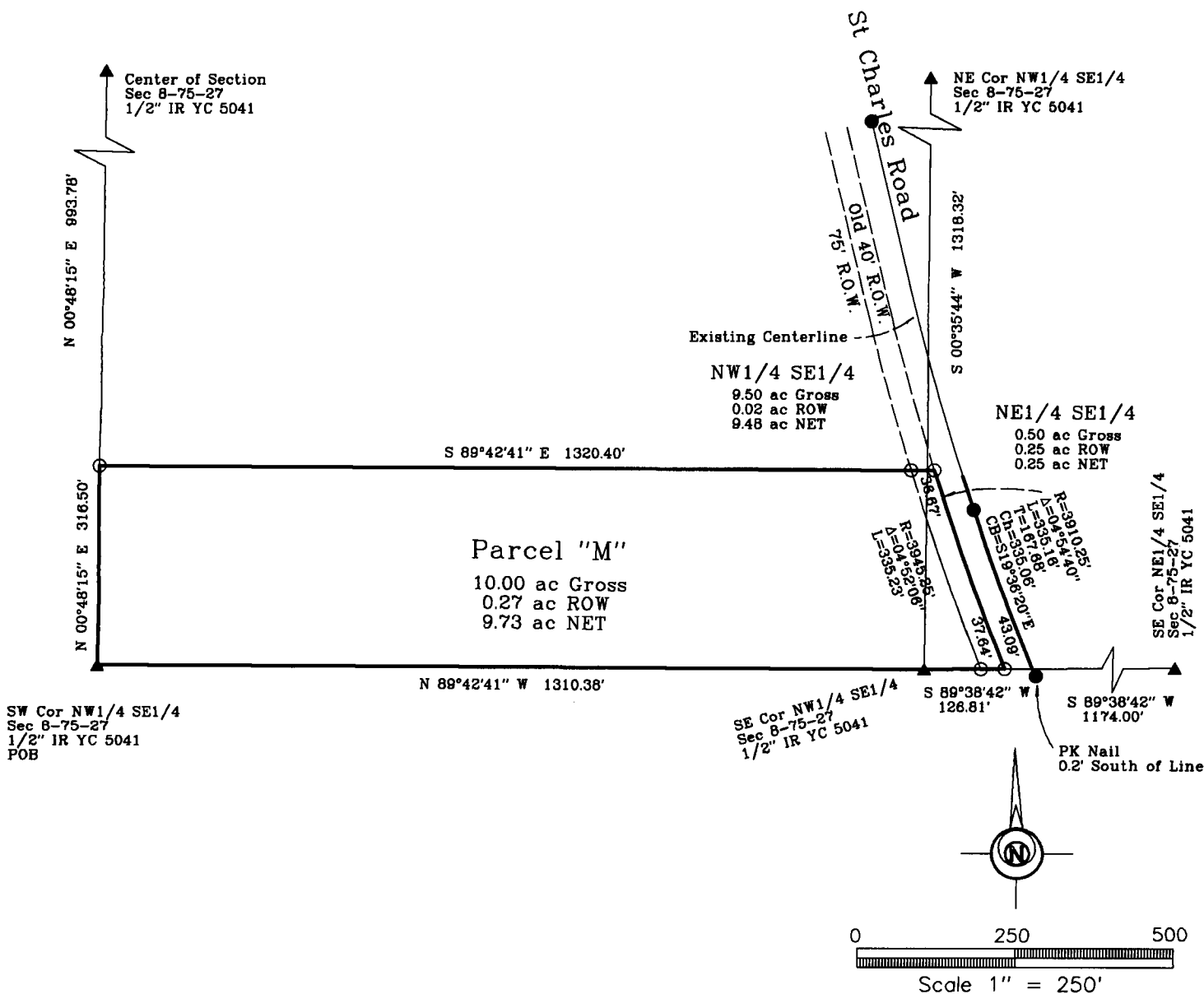

Legal Description - Parcel "M"

All that part of the North Half (N1/2) of the Southeast Quarter (SE1/4) lying on the West side of St. Charles Road, in Section 8, Township 75 North, Range 27 West of the 5th P.M., Madison County, Iowa, more particularly described as follows:

Beginning at the Southwest corner of the Northwest Quarter (NE1/4) of the SE1/4 of said Section 8, thence North 00°48'15" East, along the west line of said NW1/4 of the SE1/4, a distance of 316.50 feet; thence South 89°42'41" East, a distance of 1,320.40 feet to a point on a curve; thence along a curve to the left having a radius of 3,910.25 feet, a delta of 04°54'40", an arc length of 335.16 feet, and a chord which bears South 19°36'20" East having a chord distance of 335.06 feet to a point on the South line of the Northeast Quarter (NE1/4) of the SE1/4; thence South 89°38'42" West, a distance of 126.81 feet, to the Southeast corner of the Northwest Quarter (NW1/4) of the SE1/4; thence North 89°42'41" West, along the South line of the NW1/4 of the SE1/4, a distance of 1,310.38 feet to the Point of Beginning, and containing 10.00 acres of land, more or less, including 0.27 acres of road easement.

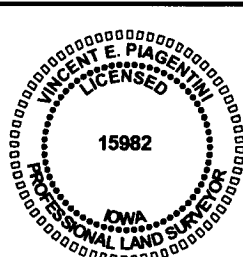
