Commencing at the Southeast corner of the West Half (½) of the Northeast Quarter (¼) of Section 3, Township 77 North, Range 29 West of the 5th P.M., Madison County, Iowa, running thence West along the South side of said quarter-section line a distance of 1166 feet to the existing North and South fence at that point, thence North along said fence line 571 feet, thence East 155 feet, thence North approximately 412 feet to the South line of the Chicago, Rock Island and Pacific Railroad right-of-way, thence Southeasterly along the South line of said railroad right-of-way, to the East line of said 80 acre tract, thence South along said East line approximately 589 feet to the point of beginning.
