## AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR ARBOR PARK TOWNHOMES

This Amendment to the Declaration of Covenants, Conditions and Restrictions of Arbor Park Townhomes is made on the date set forth below by Corkrean Development, Inc., Declarant. The previous Amendment to Declaration of Covenants, Conditions and Restrictions for Arbor Park Townhomes, filed on December 27, 2017, in Book 2017, Page 4056 of the Recorder's Office of Madison County, Iowa, is hereby amended to read as follows:

- 1. Lot Eight (8) of Arbor Park Plat No. 2, an Addition to the City of Winterset, Madison County, Iowa, which is divided into Lot 8B and 8C as shown in the revised Plat of Survey recorded on January 4, 2018, in Book 2018, Page 33 of the Recorder's Office of Madison County, Iowa, is hereby added to the Declaration of Covenants, Conditions and Restrictions for Arbor Park Townhomes recorded on April 25, 2016, in Book 2016, Page 1046, of the Recorder's Office of Madison County, Iowa.
- 2. The floor plan for the building consisting of two townhome units to be constructed on said real estate is identical to the floor plans attached as Exhibit "B" of the original Declaration of Covenants, Conditions and Restrictions.
- 3. In all other respects the Declaration of Covenants, Conditions and Restrictions for Arbor Park Townhomes is hereby ratified and confirmed.






