

Addendum

1. The North Forty-four (44) acres of the West Half (1/2) of the Southwest Quarter (1/4), EXCEPT a tract of land described as follows, to-wit: Commencing 132 feet South of the Southwest Corner of the Northwest Quarter (1/4) of the Southwest Quarter (1/4), thence East 1320 feet, thence North 30 feet, thence West 1320 feet, thence South 30 feet to the point of beginning; AND EXCEPT a tract of land described as follows, to-wit: Commencing at a point 102 feet South of the Southwest Corner of the Northwest Quarter (1/4) of the Southwest Quarter (1/4), thence East 312 feet, thence North 419 feet, thence West 312 feet, thence South 419 feet to the point of beginning, containing 3.00 acres more or less; AND EXCEPT Parcel "A" located therein, containing 3.84 acres, as shown in Plat of Survey filed in Book 2013, Page 499 on February 15, 2013, in the Office of the Recorder of Madison County, Iowa; AND all that part of the Southwest Quarter (1/4) of the Northwest Quarter (1/4) lying South of the public highway, containing 10 acres, more or less; ALL in Section Twenty-two (22), Township Seventy-five (75) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa
