Beginning at the Southwest corner of said Parcel F; thence North 00 degrees 20 minutes 31 seconds East, 81.31 feet along the West line of said Parcel F; thence South 83 degrees 01 minutes 40 seconds East, 126.78 feet; thence South 71 degrees 41 minutes 37 seconds East, 31.17 feet; thence South 55 degrees 36 minutes 09 seconds East, 101.90 feet to a corner of said Parcel F; thence North 89 degrees 39 minutes 25 seconds West, 240.00 feet to the Point of Beginning, having an area of 0.31 Acres including 0.03 acres of Madison County Road Easement.

That part of Parcel G of the Southwest Quarter of the Southeast Quarter of Section 15, Township 74 North, Range 27 West of the 5th P.M., Madison County, Iowa, described as follows; Beginning at the Northwest corner of said Parcel G; thence South 83 degrees 01 minutes 40 seconds East, 126.78 feet to a corner of said Parcel G; thence South 71 degrees 41 minutes 37 seconds East, 31.17 feet to a corner of said Parcel G; thence South 55 degrees 36 minutes 09 seconds East, 101.90 feet to a corner of said Parcel G; thence North 66 degrees 52 minutes 52 seconds West, 98.25 feet; thence North 71 degrees 41 minutes 37 seconds West, 31.17 feet; thence North 85 degrees 35 minutes 59 seconds West, 120.06 feet to the West line of said Parcel G; thence North 00 degrees 20 minutes 31 seconds East, 25.17 feet to the Point of Beginning, having an area of 0.10 Acres.
