**AFFIDAVIT OF LIEN**

- 1. I am the Association Treasurer of Covered Bridge Estates Homeowners Association, an Iowa nonprofit corporation;
- 2. The following described property is included within the Declaration of Covenants, Conditions and Restrictions for Covered Bridge Estates Homeowners Association Subdivision in Madison County, Iowa, and the Covered Bridge Estates Homeowners Association:

- 8. This affidavit is given to establish a lien on the above-described lot in favor of Covered Bridge Estates Homeowners Association.


