## **CORRECTED QUIT CLAIM DEED**

For the consideration of One Dollar and other valuable consideration, Cynthia Ann Tuttle, a single person, does hereby Quit Claim to Richard Wayne Tuttle, a single person, all my right, title, interest, estate, claim and demand in the following described real estate in Madison County, Iowa:

A parcel of real estate 100 feet wide, being the former right-of-way of the Chicago, St. Paul and Kansas City Railroad Company, its successors and assigns and located in the Northeast Quarter (1/4) of Section Twenty-two (22) and the Southeast Quarter (1/4) of the Southeast Quarter (1/4) of Section Fifteen (15), all in Township Seventy-four (74) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa. Said 100 foot strip lies Easterly of a line which commences at a point where the West line of said former right-of-way intersects with the South line of all that part of the said Northeast Quarter (1/4) of Section Twenty-two (22) which is now being purchased by Thomas L. Tuttle, Donna M. Tuttle, Richard W. Tuttle and Cynthia Ann Tuttle from Pauline Austin, and running thence northeasterly to a point where the West line of the former right-ofway intersects with the North line of the said Southeast Quarter (1/4) of the Southeast Ouarter (1/4) of Section Fifteen (15); and

The Southwest Quarter of the Southeast Quarter and all that part of the Southeast Quarter of the Southeast Quarter lying North and West of the right of way deeded to the Chicago, St. Paul and Kansas City Railway Company, in Section 15 and the North Half of the Northeast Quarter of the Northwest Quarter and all that part of the Northeast Quarter lying North and West of the right of way deeded to said Railway Company, in Section 22, except a tract commencing at the intersection of the Northwesterly line of said railway right of way with the West line of said Northeast Quarter and running thence North 522 feet, thence Easterly to a point on said railway right of way 538 feet

Northeast of the point of beginning, thence Southwesterly along said line of said right of way to the point of beginning, all in Township 74 North, Range 27 West of the 5th P.M., Madison County, Iowa, except commencing at the Southwest corner of the Southeast Quarter of Section Fifteen (15), Township Seventy-four (74) North, Range Twenty-seven (27) West of the 5th P.M. running thence North 310 feet to the Point of Beginning, thence North 190 feet, thence East 240 feet, thence South 190 feet, thence West to the Point of Beginning; and

This deed is made to correct and replace the Quit Claim Deed previously filed with the Madison County Recorder on January 5, 2015 at 9:01 a.m. as Document 2015 22, Book 2015, Page 22.
