CORRECTED AFFIDAVIT OF DEATH TERMINATING LIFE ESTATE

I, Jane E. Rosien, being first duly sworn on oath, depose and state as follows:

1. That I was well and personally acquainted with Letty J. Miller and that the said Letty J. Miller died on or about January 20, 2018, thereby terminating the LIFE ESTATE held by such decedent in the following described real estate: Two acres in the Northwest part of Lot One (1) of the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ OF NE $\frac{1}{4}$); Lot Three (3) of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ OF NE $\frac{1}{4}$); Lot Three (3) of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ OF NE $\frac{1}{4}$); Lot Three (3) of the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ OF NE $\frac{1}{4}$); Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ OF NE $\frac{1}{4}$); the East One-Half (E $\frac{1}{2}$) of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ OF SE $\frac{1}{4}$); East Eight (8) Acres of the Southeast Quarter of the Northwest Quarter (SE $\frac{1}{4}$ OF NW $\frac{1}{4}$); All in Section 14, Township 75 North of Range 28, West of the 5th P.M., Madison County, Iowa. EXCEPT the following deeded to the State of Iowa for highway purposes: Beginning at the Center of said Section 14; thence N90°00' E, 160.9 ft. along the south line of the NE $\frac{1}{4}$ of said Section 14; thence N4°28'E, 1039.5 ft.; thence N1°46'E, 791.3 ft. to a point on the centerline of Middle River, said point being 140 ft. normally distant easterly from Sta. 521+92 (Relocated Primary Road No. U.S. 169); thence Westerly along the centerline of Middle River to a point 190 ft. normally distant westerly from Sta. 518+27 (Relocated Primary Road No. U.S. 169); thence S5°26 1/2'W, 27.0 ft.; thence S2°08'E, 609.0 ft.; thence S14°30 1/2'W, 888.0 ft. to a point on the south line of the NW $\frac{1}{4}$ of said Section 14, thence N90°00'00"E, 299.1 ft. along the south line of said NW $\frac{1}{4}$ to the Center of said Section 14, the Point of Beginning; containing 15.1 acres, more or less, EXCEPT Parcel "A", located in the Southwest Quarter (1/4) of the Northeast Quarter (1/4) of Section Fourteen (14), Township Seventy-five (75) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, containing 3.372 acres, as shown in Plat of Survey filed in Book 3, Page 89 on August 12, 1997, in the Office of the Recorder of Madison County, Iowa.

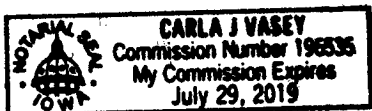
