AFFIDAVIT

- I, Margaret Ann Mallgren upon being duly sworn and deposed, do hereby state as follows:
- 1. The Affiant is Margaret Ann Mallgren, surviving spouse of J. David Mallgren, who is well and truly acquainted with the title to the real estate legally described as:

Commencing at a point of reference at the North Quarter Corner of Section Four (4), Township 75 North, Range 29 West of the 5th P.M., Madison County, Iowa; thence West 1824.7 feet along the North line of the Northwest Quarter (NW1/4) of said Section 4 to the point of beginning (this is an assumed bearing for purposes of this description only); thence continuing West 404.0 feet along said North line of the Northwest Ouarter of Section 4 to a point; thence South 2°05' East 480.3 feet to a point; thence East 250.0 feet to a point; thence North 0°40' East 216.0 feet to a point; thence North 26°55' East 296.0 feet to the point of beginning, and subject to easements of record, and containing 3.28 acres more or less.

- 4. The Decedent had no afterborn children within the meaning of Section 267 of the Iowa Probate Code.


