The Southwest Quarter (1/4) of the Northwest Quarter (1/4), and the West Half (1/2) of the Southwest Quarter (1/4) of Section Twenty-three (23); AND the South Half (1/2) of the Northeast Ouarter (1/4), and the East Half (1/2) of the Southeast Quarter (1/4) of Section Twenty-two (22); ALL in Township Seventy-four (74) North, Range Twenty-eight (28), West of the 5th P.M., Madison County, Iowa; EXCEPT a parcel of land located in the Southwest Quarter (1/4) of the Southwest Quarter (1/4) of said Section Twenty-three (23), containing 3.00 acres, as shown in Plat of Survey filed in Book 2, Page 192 on May 30, 1990, in the Office of the Recorder of Madison County, Iowa; AND EXCEPT Parcel "B" located in the Southeast Quarter (1/4) of the Northeast Quarter (1/4) and in the Northeast Quarter (1/4) of the Southeast Quarter (1/4) of said Section Twenty-two (22), containing 5.00 acres, as shown in Plat of Survey filed in Book 2006, Page 3398 on August 17, 2006, in the Office of the Recorder of Madison County, Iowa; AND the Northwest Quarter (1/4) of the Southeast Quarter (1/4) of Section Twenty-two (22), Township Seventy-four (74) North, Range Twenty-eight (28) West of the 5th P.M., EXCEPT that part thereof that lies within Parcel "A", as shown in Plat of Survey filed on September 23, 1996, in Book 2, Page 722 of the records of the Madison County Recorder, said exception containing 0.347 acres including 0.024 acres of county road right-of-way.
