Out Lot Eight (8) in the Northwest Quarter (1/4) of the Northeast Quarter (1/4) of Section Eleven (11), Township Seventy-four (74) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, EXCEPT that part thereof lying North of the center line of the creek which is the North boundary of this property, all in the Town of East Peru, Madison County, Iowa, AND

That part of the Northwest Quarter (1/4) of the Northeast Quarter (1/4) of Section Eleven (11), Township Seventy-four (74) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, bounded as follows: On the Southwest by the Southerly extension of the center line of Florence Street; on the Northwest by a line parallel with and distant 150 feet Northwesterly, measured at right angles and radially, from the center line of the main track (now removed) of the Chicago, St. Paul and Kansas City Railway Company (later the Chicago Great Western Railway Company, now the Chicago and North Western Transportation Company), as said main track center line was originally located and established over and across said Section 11; on the Northeast by the Southerly line of County Road No. 307; and on the Southeast by a line parallel with and distant 50 feet Southeasterly, measured at right angles and radially, from the center line of the main track (now removed) of the Chicago and North Western Transportation Company (formerly the Chicago Great Western Railway Company), as said main track was located prior to its removal; **EXCEPT** a tract of land located therein, more particularly described as follows, to-wit: Beginning at the middle of the intersection of Brown Street and Florence Street, thence South 200 feet, thence Northeasterly 333 feet to a point 200 feet South of the center of the intersection of Brown Street and Short Street, thence North to the center of the intersection of Brown Street and Short Street, thence Southwesterly to the point of beginning, in the Town of Peru, Madison County, Iowa; AND that part of the Northwest Quarter (1/4) of the Northeast Quarter (1/4) of said Section Eleven (11), bounded as follows: On the West by the Southerly extension of the center line of Florence Street; on the Northwest by the Southeasterly line of the above described parcel of land; and on the Southeast by a line parallel with and distant 8.5 feet Southeasterly, measured at right angles and radially, from the center line of the most Southeasterly side track (now removed) of the Chicago and North Western Transportation Company (formerly the Chicago Great Western Railway Company), as said track was located prior to its removal.
