The West 16 acres of the East Half of the Southeast Quarter of the Southeast Quarter (E½SE½SE½) of Section 27, Township 75 North, Range 26 West of the 5th P.M., Madison County, Iowa, except that part thereof deeded for cemetery purposes and described as follows: Beginning at a point 692 feet North and 132 feet West of the Southeast corner of said Section 27, thence North 8 rods; thence West 20 rods; thence South 8 rods; thence East 20 rods to the place of beginning, Madison County, Iowa.

The Southwest Quarter of the Southeast Quarter (SW¼SE¼), and the West Half of the Southwest Quarter (W½SW¼) and the Southeast Quarter of the Southwest Quarter (SE¼SW¼) of Section 26, and the East 4 acres of the Southeast Quarter of the Southeast Quarter (SE¼SE¼) of Section 27, Township 75 North, Range 26 West of the 5th P.M., Madison County, Iowa.

The East One-half of the Southwest Quarter (E½SW¼) of Section Thirty-six (36), Township Seventy-five (75) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa,

EXCEPT a tract bounded by a line commencing at the Northwest corner of the East One-half of the Southwest Quarter (E½SW¼) of said Section Thirty-six (36); thence Easterly along the Northern boundary line of the said East One-half of the Southwest Quarter (E½SW¼), a distance of 250 feet; thence South 523.2 feet; thence Westerly 250 feet to the West line of the said East One-half of the Southwest Quarter (E½SW¼); thence North 522.7 feet along the West boundary line of said East One-half of the Southwest Quarter (E½SW¼), to the point of beginning, Madison County, Iowa.
