that the following described parcel:


Lots Five (5) and Six (6) in Block Eight (8) of the Original Town of East Peru,

situated in the County of Madison and State of Iowa, was subject to taxes for the year 2015-2016 A.D. and the taxes on the parcel for the year (or years) stated remained due and unpaid at the date of the sale; and the Treasurer of the County, on the 22nd day of June, A.D. 2016, by virtue of the authority vested by law in the Treasurer at (an adjournment of) the sale begun and publicly held on the third Monday of June, A.D. 2016, exposed to public sale at the office of the County Treasurer in the county named, in substantial conformity with all the requirements of the statute, the parcel described, for the payment of the total amount then due and remaining unpaid on the parcel, and at that time and place, Logical Payments Inc. of the County of Madison State of Iowa, offered to pay the sum of One Hundred and One DOLLARS (\$101.00) and zero Cents, being the total amount then due and remaining unpaid on the parcel, for 100 percent undivided interest of the above-described parcel which was the least quantity bid for, and payment of that sum was made by that person to the Treasurer, the parcel was stricken off to that person at that price.


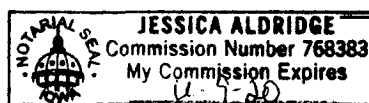
